A faculty supervisor or other employee who attends a club's off-campus meeting or activity does so outside the scope of his/her employment and is acting in the capacity of an individual unaffiliated with the school or the District. The individual is not authorized to act on behalf of the District and is not covered by the District's liability insurance. If members of the club engage in off-campus activities, the District provides no supervision or oversight, nor does the District's liability insurance cover these activities.
2. That participation in this club may expose my student to certain unavoidable, unpredictable, and inherent risks and dangers.
3. That my student is expected, and has been instructed by me:
 - A. To follow all instructions given by school advisors.
 - B. To follow all Nebo School District policies and to comply with any and all applicable laws and rules.
